3. Committee Reports

- Finance Committee/Financial Report (John Rich)
 - PowerPoint Review see meeting documents on Insider Page
 - 93% assets in cash; non-cash assets of \$67,000.
 - Cash presently held in 4 accounts at 2 institutions E. Mao will be investigating how we hold these funds/how to reorganize.



- NEUAC liabilities have increased from last year due to credit card expenses, deferred vacation, credit card fees – normal to get us transparent on our liabilities (minimal of our overall cash amount – 2.4%)
- o Annual audit completed, IRS form 990 completed, staff retirement fund analysis completed
- Coming Year Goals:
 - Completed ICS account (Insured Cash Sweep)
 - Work on communication of financial status to the Board
 - Work on asset retention procedure Finance Committee

• Conference Committee (Rhonda Harper & Katrina Metzler)

- o Conference team meeting regularly sent out Save the Date
 - Call for Presentations closes Friday, December 3
- o Theme: "Rising with Resiliency" draft schedule in board packet
 - Enough room in schedule for pre-conference: Racial Healing Circles, Water Affordability Summit, LIHEAP Summit (proposed ideas)
 - Plenary sessions proposed "Dream Team for Energy Equity" (Shalanda Baker, Tony Reames, Chandra Farley); Ramsey Greene, Chief Resiliency Officer, New Orleans, HHS Dialogue with the Feds, Jennifer Granholm, Secretary of Energy, more to come
- o On track for the conference preparations at this point
- Open discussion regarding COVID-19 variants and terms of contract with hotel contract negotiated pre-pandemic (no COVID language)
 - Will use force majeure if needed if impossible or impracticable to hold the event, can negotiate to get out of the contract
 - Hotels often challenge us here usually cannot enforce this clause until 60 days (or so) prior to scheduled start of conference
 - Revisit after winter registration will not open until April 2022

Membership/Fundraising (Steve Whitworth)

- Campaign kicked off October 1, 2021
- 2022 Goal: 230 members
 - 72 members have renewed or joined, at this time (31 nonprofits, 12 gov, 12 utilities, 3 trades, 3 tribes, 2 munis, 1 corporation, 6 unclassified)
 - 2021: 29 new members
 - Membership count is slightly ahead of 2020
- o Fundraising goal of 5% increase in revenue
 - Currently at \$90,000 of a \$430,219 goal (slightly behind this time in 2020 behind on getting out renew reminders, per Katrina)
 - Focus on active fundraising methods will be conducting outreach
 - Board member challenge get the word out and pick up new members, follow up with members that have yet to renew
- Open discussion on how to involve the conference in driving membership



- (ex) Conference Members -Only Reception; on-stage advocacy by the Membership/Fundraising team; submit additional ideas to Katrina
- Public Policy & Advocacy (Brian Caudill & Allison Bury-Poe)
 - Policy Update
 - LIHEAP \$3.75b after 2021 appropriated funds; throughout year received another \$4.5b via the CARES Act -- \$8.25b total (most in the history of the program)
 - About \$55m in emergency rental and mortgage assistance (Treasury Department) out of which utility assistance could also be paid – continue to be available for next few years
 - FY 2022: Expect Continuing Resolutions (CR) same funding method of 2021
 - No appropriations bill interest in Congress, at this time
 - Same budget number as last year currently operating for this year funds went out to states around November 1
 - House moved legislation for continued incremental increase (\$150m increase or so) we've been receiving for last five or six years
 - Bipartisan Infrastructure Bill: supplemental \$500m for LIHEAP
 - Will be spread out at \$100m/year for the next five years; likely HHS will do
 another calculation this year as money has become available after initial release
 of funds; funds are not yet distributed
 - This is the only item we are sure of, funding wise much uncertainty surrounding appropriations package potential
 - Extra Mile Award (to member of Congress that is a LIHEAP ally)— LIHEAP Action Day
 - Not yet decided, but in process; suggest nominees to PP&A committee or email/message Brian or Katrina
 - Suggested in chat: Chris Coon (DE) Haly Laasme
 - Vote will be made on recipient by January
 - Last year's award went to Senator John Hoeven (ND)
 - LIHEAP Action Day: February 23, 2022
 - Training week before; virtual event (COVID-19 and security concerns on the Hill preventing an efficient in-person event)
 - Registration opening sometime this month (December)
 - All Parties Letter will be released simultaneously goal is 1,000 signatures (slightly short in 2020)
 - Annual letter laying out support for LIHEAP and makes initial pitch for how we hope it will be funded in the next year
 - Goal get as many signatures as possible to show support (upwards of 2000 signatures on the letter in the past)
 - Any entity dealing with home energy assistance, energy poverty is welcome to sign, regardless of whether they are a NEUAC member organization
 - Open Discussion: ERA Funds
 - ERA 1 extended to 2022
 - ERA 2 (coming out of America Rescue Plan) extended through 2025
 - Some states seeing reauthorized funding redistributions
 - How to get funds out to the customer quickly open discussion offered offline

• Executive Committee (Rhonda Harper)

- Advocacy Associates Contract referred to organization by Brian Caudill (AGA)
 - Additional \$20,700 costs, as discussed in last meeting, but essential for us to have them to put on a virtual LIHEAP Action Day event
 - Gerri Drummond: Asked TECO to donate an extra \$1000 toward costs not yet received check
 - Proposal for each utility to provide an additional \$1000 to offset costs
 - Faye Kinner: Atmos Energy pledge \$1500
 - Bridget will send invoices to entities pledging after meeting
 - Silvia Aldana: PG&E pledges to offset costs (no amount provided)
 - Kim Campbell: TXU pledges \$1500
 - Several entities volunteered to offset costs in last board meeting please email
 Katrina with pledge amounts
 - Will be some logistical work with Advocacy Associates and utilities advocates that are typically in DC and set up their own appointments



- Bridget and Katrina have met to discuss and believe registration tool will capture this information
- Registration tool will ask you to tell NEUAC which meetings you'd like to attend OR allow NEUAC to schedule your meetings
 - Open discussion on how lobbyist role in scheduling appointments changes
- Registration should launch sometime next week
- Executive Committee approved for Katrina to sign contact with Advocacy Associates need a vote to ratify Executive Committee's decision to
 - 1st: Saunteel Jenkins
 - 2nd: Enrique Hernandez
 - Motion Passes
- LIHEAP.org Ongoing Discussion—What should it be?
 - Katrina, Bridget, Rhonda met with Michael Bracy to pitch purchase of LIHEAP.org from him – feel it is more appropriate for NEAUC to own it
 - History: Organization "Campaign for LIHEAP" operated by a K-St. firm Bracy works with he was in charge with LIHEAP
 - Firm worked with utilities to advocate for LIHEAP
 - Role diminished over time sunset campaign for LIHEAP in 2019
 - Michael and team retain rights to liheap.org "stranded asset" not currently maintained
 - Michael seeking a way to make website relevant; approached NEUAC and other national partners about coming together for a mutual agreement to maintain the website
 - Issue: No resources (staff, funding) to maintain website to the level it needs to be; we
 do not own the asset would be developing asset for another entity
 - Executive Committee would like to see ownership and take credit for developing the asset, should we get involved
 - Status: Michael asked for time to think about it; Executive Committee will revisit the issue
 - Also want to discuss not duplicating what is available at LIHEAP Clearinghouse (recently relaunched); National Energy Assistance Referral Hotline also being updated to send to local offices within the next month
 - Open discussion of using benefits.gov to learn about LIHEAP only works for states with threshold at 150% of poverty (not above nor below); how do we make new information relevant for each state?

4. Executive Director's Report (Katrina Metzler)

- Welcome to Erin Mao getting oriented to take on tasks
- Re-presentation of 2022 Budget Overview
 - Finance Committee asked for re-presentation after incorporating retirement and health insurance, as well as Advocacy Associates pledges
 - With new incorporated costs, still about \$18,512 in the hole



- Treasurer encouraged Katrina not to go make cuts in other areas; we may need to dip into reserves to get into this year; have not incorporated pledges made for Advocacy Associates assistance at this meeting
- Budget includes meeting fundraising goal of 5% for 2022 even with meeting that goal, we will still be in the negative
 - Revenue from pledges is booked in the year NEAUC receives the pledge
- This budget reflects an update in payroll tax line item only includes portion of FICA NEUAC pays instead of all taxes coming out of NEAUC paychecks creates a more transparent budget that demonstrates clearer salaries for NEAUC staff; numbers are the same at end of line item, but reorganized for increased transparency
- o Reminder: The budget is a projection of what NEUAC intends to do/raise in FY 2022
- Rhonda called for a motion to approve the revised budget, with the incorporation of retirement, healthcare, and Advocacy Associates costs
 - 1st: Nancy Loehr
 - 2nd: Chere Coleman
 - Motion passes
- Energy Affordability Policy Discussions
 - Emphasis on providing cooling assistance; PP&A discussing \$5.1b request for LIHEAP Action Day to provide resources for this endeavor
 - Heavy media coverage of energy affordability—particularly projected increases and costs of heating
 - CNN article quoting Katrina and Mark (NEADA)
 - Washington Post Massachusetts and Arizona weather and affordability issues
 - NEADA's website links to media coverage
 - Collaboration with National Consumer Law Center (NCLC) regarding medial protections
 - ICU physician working on project what seeing in field regarding energy affordability needs in the emergency room/ICU
 - Paper and RFP for NEAUC conference forthcoming with additional information on this project
