NEUAC honors the legacy of Sister

Pat Kelley by bestowing an annual award in her honor to a person with exemplary achievement in furthering NEUAC's objectives of increasing public awareness of low-income energy problems, advancing energy assistance policy, and promoting charitable energy assistance.

Missouri EnergyCare eventually spurred the creation of the National Fuel Funds Network and later NEUAC, with a mission to advocate for energy assistance.

Nun uses persuasive powers to help St. Louis' poor, elderly

ST. LOUIS (AP) - Katharine Stevenson, a 74-year-old widow, was nearly \$500 behind on her gas bill and the weather was nearzero. She needed help fast.

A social worker referred her to Sister Patricia Kelley, a 47year-old Irish Catholic nun who is a persuasive advocate for the poor.

"Sister Kelley gave me \$300 and they kept my gas on. I was so grateful. No one ever helped me out before." Mrs. Stevenson, who has high blood pressure and arthritis, said of the January incident." I spen three months without heat last year because my gas was cut off."

Sister Kelley is executive director of Missouri Energycare Inc., a non-profit organization that helps the needy pay emergency utility bills. Her agency, the only one of its kind in the state, relies entirely on contributions and receives no government funds.

"We do a lot of begging," she said in an interview at her basement office in the Saum Hotel in south St. Louis. "We try to get everything we can for free, then we stretch it as far as possible."

Her office, for example, was donated by the hotel owner. The furniture is on loan from a local utility.

"I'M LIVING the way nuns have always lived," she said. "We're very creative and innovative. I've picked up a lot through osmosis."

A life dedicated to service

During her professional life, Sister Pat worked as a teacher, vocational counselor and volunteer probation and parole officer in hospitals and in pastoral service.

After 25 years of religious life, Sister Pat went to Sedona, Arizona in 1980 for a yearlong retreat. She returned determined to devote the rest of her life to helping the poor and elderly.







In March 1981 Sister Pat was selected to administer a one-year \$20,000 grant from the National Council of Senior Citizens. The grant established "Missouri Project EnergyCare" to assist limited- and fixed-income elderly with energy related needs.

She served as the organization's president and executive director.





Gone too soon...

On Monday September 28, 1987, Sister Pat's life was cut short by a senseless act of violence.

News of her death made headlines. A St. Louis Post-Dispatch editorial stated that "she raised not only money – she also raised the consciousness of those who could make a difference in the plight of those who too often have to do without."

His accomplishments include:

- Program Manager; U.S. DOE WAP implemented updated technical standards; increased program production by 20 percent -
- Oversees seven Ohio utilities programs; three fuel funds; \$14 million budget
- OPAE members helped low income Ohioans save 15,755,162.00 kWh in energy; weatherized 11,204 homes (2019)
- Secured increased funding for Ohio's energy assistance programs (2019)
